Unanimously agreed that the amended minutes of the meeting held on the 16th March 2021 are adopted as a true statement. The Chair to sign the minutes at a later date.

05/05/7 TO RECEIVE REPORTS FROM THE COUNTY AND DISTRICT COUNCILLOR

Key points included worse of potholes have been filled in on Mildenhall Road, to be resurfaced later this year; flooding issues on road running along Lark's Gate to be discussed at a meeting in May with Anglian Water, SCC, Environment Agency; granting of temporary permits for HGV's, full list when expired has been requested.

05/05/8 PUBLIC FORUM

To receive questions and issues raised by the Public on matters relating to the agenda under discussion and matters relating to the village.

No members of the public were present.

05/05/9 TO RECEIVE REPORTS FROM PARISH COUNCILLORS RELATING TO PORTFOLIOS HELD

Cllr Emerson River Lark - attended the Pollution meeting lead by Jo Churchill at the end of March. Many problems were identified in the reports presented, River Lark Pollution Review and Action Plan, authored by Geoff Brighty and the Lark Catchment Appraisal, authored by Sam Hurst. The operational performance of Fornham WRC was a large part of the discussion. River Lark Catchment Partnership have been tasked with leading the initiatives to combat some of the issues on the Lark. Footpath A1101 Fornham All Saints to Hengrave, met with Charlie Browne about a permissive footpath, he wishes to discuss this further in conjunction with his future plans for Moseleys Business Centre. He would like to meet with the Parish Council in June to present his plans. A Dropbox account to store information has been set up, businesses in Fornham All Saints have been contacted and I am waiting for completed GDPR's. Three Kings, new landlords took over 29th April 2021. There are several new businesses in Moseleys Business Centre all of which have been contacted.

Clir Purnell Bench in the Memorial Garden now refurbished and back in place. Playground Safety reports have raised some minor issues for which I will be getting specialist quotations. Previously, it was decided the top gate between the allotments and the playing field should be permanently closed. It was agreed that the gates be welded together and extended upwards with a framed steel mesh to create a deterrent to climbing over. It is reported that there are a number of derelict and possibly dangerous sheds at the allotments. A skip to be ordered to remove these. Clir Gathercole Heritage trees inspected again with only one that has not survived. The rainbow seeds at the bus stop are getting greener. Muntjacs are active in Pigeon Lane. The Marham Park trees are growing well. Ongoing problems with dog mess. Most of the allotments are looking good. Nothing heard from Jo Metcalfe about the swift boxes, I have tried to contact her but had no reply. A working party is needed to clear the edges of the tarmac track in Pigeon Lane, small trees are growing in the tarmac, and overhanging branches will soon cause cyclists a problem, edges of the track need cutting back along with trailing blackberry runners.

Clir Mayhew Meeting with RCC this coming Friday. Recommencing Caravan 2nd June in Village Hall. Details to follow. Magazine update, no new advertisers. Review of distribution, investigating creating an on-line edition.

Cllr Lynch No meeting as yet with Highways on matters of traffic i.e. Weight – Volume – Speed. In discussion with Keith Salmon (Highways) about a new post at the Forge End Site, has been ordered but can take up to 14 weeks to be sited. I am in discussion with Jonathon (ANPR Highways) as we will be part of the testing of the new portable ANPR. Site conversation with Highways Portable VAS Unit this week. I understand that unit measures speed and volume but not vehicle reg. A report to be sent on any findings. Number of email conversations with Lorry Operators over the past few months and received favourable responses back save for Eastern Concrete.

Clir Greer-Walker Quiet Lanes Suffolk and Tut Hill consultation to be discussed in full within the Parish Council meeting.

Cllr. Stewart Failed tree and hedge planting is taking place from this week up until the end of the month, the pine trees that have failed will not be replaced with like for like trees, Countrywide are awaiting approval for different species. Grassed areas in the middle section of the site will be weed killed and sprayed mid-April when warmer, then wildflower mix will be spread. Grass area adjacent to Mildenhall Road end will follow. One play area is finished, second area hopefully to open end of Spring. The large playing fields are due to be finished and open late 2021, however this is dependent upon areas available for construction equipment and machinery as a safe working zone will be required. Tut Hill junction works were undertaken to try to eliminate the vehicles turning, however there are some persistent users who have disregarded signage and physical forms, concrete blocks or barriers are not permitted, the area is due to be tidied up and fast-growing seed mix applied to try and stabilise the area. SCC are happy with what they have done and are now wanting to get the road adopted, hence these will then become traffic enforcement issues. Beccy has been contacted requesting some assistance in what we need to do to get S106 monies for the footpath link from Tut Hill to the park area. The builder's yard, waste, and material storage area on Pound Meadow has been cleared.

Positive feedback from advertised route. Although signage costs at either end of Mere Lane are guaranteed to be met by Highways, to help provide further Quiet Lanes, the Parish Council agreed to contribute the sum of £250 towards the project. Risby Parish Council will be holding their public consultation tomorrow. Second stage this summer.

An updated valuation for the land in question to be obtained a) land as it is b) reduced land area once a footpath is in situ. Concerning safety issues with crossing the road from a new path, Highways and Marham Park to be consulted on the proposal. Cllr Greer-Walker and Cllr Stewart to action. Consideration to be given for planting more trees with, or without a new footpath. Sicon Foundation, a charitable organisation for planting and maintaining trees at zero cost to the PC to be contacted. Cllr Gathercole to action.
