#### 15/11/65 ELECTION OF CHAIRMAN

It was proposed and seconded that Cllr Enid Gathercole be elected Chairman – unanimously agreed.

#### 15/11/68 MINUTES

Proposed and seconded that the minutes of the meeting of Tuesday 6<sup>th</sup> September 2022 and Tuesday 4<sup>th</sup> October 2002 are adopted as a true statement.

#### 15/11/69 PUBLIC FORUM

There were no members of the public present.

#### 15/11/70 TO RECEIVE REPORTS FROM THE COUNTY AND DISTRICT COUNCILLOR

Cllr Hopfensperger's General Report was previously circulated. No date yet set for a site meeting with SCC to discuss a new pedestrian crossing; planning appeal for Dream Lodge, Fornham St Genevieve, at the request of Natural England a further site visit has taken place, outcome will not be forthcoming for at least 3-4 weeks; with reference to the planning application received from M&D Developments to create access into All Saints Country Club from The Steet, Fornham All Saints, the planning officer and Highways have been asked to ensure that adequate consideration is given to the fact that access will be going over a drainage ditch; still awaiting the planting scheme to replace the poplars; diversion of the footpath is temporary at present but an application is to be submitted to Rights of Way to make it permanent; rather than signage to reduce speeding in Forge End, the care companies will use their contract officers to put a note out asking drivers to be aware of pedestrians; the skirting back throughout the village has been included in the works programme, no date yet when this is to be carried out; the new Community Liaison Officer at Highways has arranged for drains at the bottom of Tut Hill to be flushed out and WSC are to kerb clean; it is anticipated work to close Tut Hill will commence in the Spring; following a conversation with a representative from Marham Park, Cllr Stewart asked RH whether the S106 monies set aside for the footpath could now be put on the road rather than the field.

## 15/11/71 TO RECEIVE REPORTS FROM PORTFOLIOS HELD

Cllr Don Lynch: Heavy lorries going through the village have increased. Cargate, who empty at Anglian Water come through an average of ten times per day from 6am including weekends. All breach's should be reported direct to the companies; a conversation needs to be had with the permit exemption team who are signing off and extending permits without any recourse on the impact to Fornham all Saints.

Cllr Matin Loveridge: The six Quiet Lanes signs have been picked up from Ipswich, two volunteers needed to put them up, poles already in situ. Regarding the play area, nothing of a serious nature to report. A proper handover with Paul Purnell to be arranged. Cllr Enid Gathercole: When the seeds have dropped, RT has again offered to cut down the wildflowers; a resident would like to make a grassed area on Dairy Drive into a spring garden, neighbours are currently being consulted, RH to check ownership. Works to be carried out from the 25<sup>th</sup> November for five days to repair the kerb edges in Pigeon Lane. Cllr Cathy Emerson: Flyers with useful contact details and dates of when the Rural Coffee Caravan will be in FAS have been distributed to all homes; RLCP are continuing to carry out work in the river.

Cllr Jill Mayhew: Rural Coffee Caravan had a successful vaccination programme with 17 attending. Next visit to FAS will be 7<sup>th</sup> December with three sessions booked for next year; old village voice magazines to be recycled; WI information on the website to be updated; a local contractor to be asked to quote for cleaning the roof of the bus stop, the cost to be circulated for approval.

Cllr Matt Stewart: Along with Cllr Greer-Walker, met with a representative from Marham Park, area where shop is to be located has been sold, not definite but could be a Co-op; gates are not going to be changed; trees that were originally planted and are now dead are currently being removed; the development is be adopted by the council in the next six months.

#### 17/11/72 TO RECEIVE THE CLERK'S REPORT

The three new litter/dog poo bins have been delivered and will be installed shortly. There will be one quarter allotment vacant at the end of December, waiting list will then be reduced to two.
